#### **Technical Information**

- We recommend a minimum of 32 stitches per 10 cm (8 stitches per inch) and seams must have a minimum 12mm (0.5") bite on the fabric.
- Not suitable for use as removable loose covers.
- Please note that all fabric offered is subject to minor tolerance in respect of shade and other slight variations
- Technical specifications may be amended, please check for the latest information

#### Fabric Care

- Use a vacuum cleaner or soft brush to remove dust and solid particles.
- Always try cleaning products on a hidden piece of fabric to test suitability.
- Wipe frequently with a damp cloth to maintain the appearance of the fabric.
- All spillages should be removed immediately with a clean absorbent cloth.
- Poorly fixed clothing dyes, e.g. Denim, will cause permanent staining. Most stains can be removed using cold/warm water and a clean microfibre cloth.
- Stains from products containing oil and grease should be treated with a spirit based solution.
- Can be steam cleaned in situ.




